PREFACE

It was the rows of nineteenth century publications on Sri Lanka, written by the British in the colonial era, at the S G Perera Memorial Library at Tulana Research Centre, Gonawala, Kelaniya, and the sense that the meeting between the British and Buddhism in the nineteenth century had not been adequately covered, although very relevant to the twentieth century, which led to the theme of *Crisis, Competition and Conversion*. The actual research, however, took me far beyond the walls of Tulana Research Centre and I am equally indebted to the following: National Museum Library, Colombo; the Library of the University of Peradeniya; the Buddhist Publication Society, Kandy; the Archives of the Methodist Church, Colombo; the libraries at the Headquarters of the Baptist Sangamaya and the Cathedral of the Church of Ceylon, Colombo; the Archives of the Overseas Division of the Methodist Church and the Church Missionary Society, U.K.
